THINK TANK Budget Planning | Trillium A

1.3 Commissioning for Service-Focused Outcomes | Algonquin CD

Commissioning is a principal means by which many jurisdictions are reorganizing and redesigning their human service delivery models to meet growing demands within a context of fiscal restraint. The most common definition of commissioning, coined by the Institute for Government, has three components: assessing the needs of people or users in an area; designing and specifying services to meet those goals; and choosing the delivery mechanism to secure appropriate services. A nuance emerging out of Canada and Australia specifies a fourth component: deciding the role of each actor in the service delivery value chain by relative value proposition.

Commissioning involves active management of public, private and non-profit service providers who are focused on delivering agreed-upon outcomes. This approach represents a significant change for many governments, requiring new partnerships and a collaborative approach. Under a commissioning framework, public sector managers will need to engage differently with system users to understand their needs and goals and to determine the key enablers of successful delivery. This approach can also lead to service providers leveraging demonstrated results to compete for funding. Using real world examples from Ontario, Canada and other countries, presenters will provide insight into the following questions:

- What is meant by "commissioning" and how does it work in practice?
- What challenges does it present for public sector managers and service users?
- How can governments incentivize the right types of behaviours, recognizing that some outcomes are not within the service provider's control?
- How can all parties build trust to create a more collaborative culture, support new efforts and enable the risk-taking required to make this approach a success?
- How can we ensure that providers don't focus resources on 'easier' cases at the expense of more challenging ones? (sometimes referred to as "parking" and "creaming")

3.3 Community Safety and Well-Being Planning: A Practice Perspective Algonquin AB

By January 2021, Ontario municipalities are mandated to prepare and adopt a Community Safety and Well-Being (CSWB) Plan based on requirements under the *Police Services Act*. CSWB planning is a proactive, multi-sector approach to identify and respond to local priority risks to safety and well-being. As key partners in the human services sector, it is important for Consolidated Municipal Services Managers and District Social Services Administration Boards to be aware of the emergence and importance of CSWB planning. The session will begin with an overview of the new legislative requirements and CSWB Planning Framework from the Ministry of the Solicitor General. Next, representatives from Halton Region and the Halton Regional Police Service will share perspectives and insights as early adopters of CSWB planning.

3.4 Home for Good: Partnerships in Housing and Mental Health Algonquin CD

There is a growing recognition in community housing of the need for a variety of supports to ensure successful tenancies, prevent evictions, and end the cycle of homelessness, but housing professionals may be ill-equipped to address these needs alone. Partnerships with mental health and addictions service providers are one way to address these gaps.

This session will explore the District of Thunder Bay Social Services Administration Board's (TBDSSAB) experiences in working with Dilico Anishinabek Family Care and St. Joseph Health Care to address homelessness coupled with mental health and addiction issues through their *Home for Good* program. With support from the Province, the initiative has committed multi-year funding to help service managers house homeless individuals and connect them with the right supports.

Through Home for Good, TBDSSAB works with partners to identify individuals who are homeless or at risk of homelessness, determine their individual needs for housing and supports, and address the unique needs of this population. The program accesses a variety of housing models, including independent living with basic supports, independent living with in-depth supports, transitional supportive housing arrangements and long term live-in supports for those with the greatest need.

Participants will hear about the program's promising results over the past two years and the case for expanding the initiative. The speaker will also explore how further collaboration and service delivery between housing service managers and mental health and addictions providers, supported by the Ministry of Municipal Affairs and Housing and the Ministry of Health and Long-Term Care, could lead to a stronger support system with additional resources committed to the elimination of chronic homelessness.

THINK TANK Strategies for Serving Hard-to-Reach Clients | Trillium A

In this interactive session, facilitators will use the case study below to explore the complicated problem of how to assist clients with very violent and destructive behaviours to achieve stability. During six table discussions, participants will discuss barriers preventing clients from achieving desired outcomes; resources needed to proactively manage cases from a short-term and long-term perspective; gaps in services and ways to fill those gaps; how to measure success; and how OMSSA can provide support, advocacy and policy development.

Billy is a 41-year-old man who was living in an RGI unit. He has been diagnosed with a concurrent disorder and has a history of violent and theft related crimes. Billy recently destroyed the property at his RGI unit while using crystal meth. Billy frequently terrorizes other residents who complain to the Property Manager, who refuses to file formal complaints with Police. Billy recently assaulted a visitor to the complex, which led to criminal charges and a brief stay in jail. During this time, Billy was evicted from his unit. Under new social housing legislation, the provider has exercised their right to not allow him back into his unit or on the list for a vacancy in the foreseeable future. You have tried to get him a secure bed in a shelter, but he was banned from all local shelters due to theft and assaults. He now mostly lives on the street. Complaints about his behaviour have been forwarded by businesses to the Mayor and Regional Councillors, and your CAO has asked for your assistance. After making a few calls, you learn he has essentially taken over his former neighbour's social housing unit. His former neighbour claims that Billy is a guest but it's clear she is too intimidated to resist because she fears for her safety.

4.2 Human Services Integration Best Practices | Algonquin ABCD

This session delves into the successes, unexpected challenges, and lessons learned by jurisdictions that have moved forward with ambitious human services integration reforms. Attendees will hear about the fascinating evolution of the United Counties of Leeds and Grenville's current approach to integration and what they learned along the way. Next, speakers from Waterloo Region's Community Services Department will discuss their four-year path toward integration, culminating in the recent launch of integrated reception and an integrated team service delivery approach. Along the way, Community Services redesigned its physical space, rolled out a new shared scheduling tool, overcame policy misalignments, and improved relations with the union representing staff members. Attendees will also learn about international best practices – what works and key criteria – and have lots of opportunity to engage in dialogue with the speakers.

4.3 Shifting to Data-Driven Social Services | MacDonald

In times of scarce resources, it's essential that social services providers use data to guide planning and service delivery, and to direct resources toward areas that provide the most return on investment and benefit to individuals and communities. Shifting toward "data-driven" social services reduces guesswork and also aligns with the Province's emerging Data Strategy, which identifies "better, smarter government" as one of its main goals. In this session, attendees will learn about leading practices from other jurisdictions on how to maximize benefits using data, as well as how municipal social service providers in Ontario are using data to guide planning and service delivery. They will also interact with panelists and discuss the possibility for a provincial social services data analysis event.
